**SUPPORTING AND ENDORSING THE COMPLETION OF A RURAL ADDRESSING  
SYSTEM AND THE DEVELOPMENT AND IMPLEMENTATION OF A NAVAJO NATION  
ENHANCED EMERGENCY 9-1-1 SYSTEM**

**WHEREAS:**

1. Pursuant to Local Governance Act, Section 103, (A), the Ojo Encino Chapter is a certified and recognized Navajo Nation Chapter to enact on matters that addresses the concerns of its local population; and
2. The Ojo Encino Chapter is aware of the need for a Navajo Nation-wide Enhanced Emergency 9-1-1 System for any sudden occurrences of emergencies and recognizes the importance of having a system in place; and
3. The Ojo Encino Chapter acknowledges the need for establishment of an Enhanced Emergency 9-1-1 System on the Navajo Nation to improve adequate communications and expedite emergency services; and
4. Furthermore, the Ojo Encino Chapter genuinely believes those communities within Navajo Nation will not only benefit the people but also public businesses, health care facilities, educational institutions, fire districts, emergency rescue personnel and police district.

**NOW THEREFORE BE IT RESOLVED THAT:**


1. The Ojo Encino Chapter hereby respectfully submits its support and endorsement in the implementation of a Rural Addressing System.
2. The Ojo Encino Chapter is committed to helping maintain the accuracy and subsequently a Navajo Nation Enhanced Emergency 9-1-1 System, an effort by and through the Communications and Utilities Department of the Navajo Nation Division of General Services.
