#### RESOLUTION OF TEEC NOS POS CHAPTER

TEEC NOS POS CHAPTER SUPPORTING AND ENDORSING THE COMPLETION
OF A RURAL ADDRESSING SYSTEM AND THE DEVELOPMENT AND
IMPLEMENTATION OF A NAVAJO NATION ENHANCED EMERGENCY
9-1-1 SYSTEM

### WHEREAS:

- The Teec Nos Pos is a Certified Chapter of the Navajo Nation established and recognized by the Navajo Nation Council as a foundation of the Navajo Nation government vested with the authority to plan and implement projects in the best interest of the community. See generally, 2 N.N.C. §4021 et seq. and 26 N.N.C. §102, and
- 2. Pursuant to 2 N.N.C. §102(A), the Navajo Nation Council is governing body of the Navajo Nation; an
- By resolution CAP-34-98, the Navajo Nation Council approved the "Local Governance Act" wherein the Navajo Nation Council delegated governmental authority to the Chapters of the Navajo Nation to address matters of local concerns with Navajo law, custom and tradition; and
- The Teec Nos Pos Chapter is aware of the need for a Navajo Nation-wide Enhanced Emergency 9-1-1 system for any sudden occurrences of emergencies; and
- The Teec Nos Pos Chapter acknowledges the need for establishment of an Enhance Emergency 9-1-1 System on the Navajo Nation to improve adequate communications and to expedite emergency services; and
- Teec Nos Pos Chapter genuinely believes those communities with the Navajo Nation will
  not only benefit the people, but also public businesses, health care facilities, educational
  institutions, fire districts, emergency personnel and police districts.

#### **NOW THEREFORE BE IT RESOLVED THAT:**

 Teec Nos Pos Chapter hereby respectfully submits its support and endorsement in the implementation of a Rural Addressing system, commitment to help maintain the accuracy and subsequently, a Navajo Nation Enhanced Emergency 9-1-1 System, an effort by and through the Communications and Utilities Department of the Navajo Division of General Services.
